



Participant Release of Liability, Assumption of Risk and Indemnification Agreement

**** Read Before Signing ****

In consideration of being allowed to participate in Pucks N Pups at U.S. Bank Arena on either November 17, 2018 or March 20, 2019 (the "Event"), the undersigned, acknowledges, appreciates and agrees that:

- I am an adult over the age of 18, and I have read, fully complied with, and agree to be bound by all terms and conditions of the Event.
- I certify that I am the owner of and have custody of the dog that I have brought to U.S. Bank Arena. I and my dog are physically able to participate in the Event. I further certify that my dog is current on the following vaccinations:
 - Rabies - given annually, but sometimes can be a 3 year.
 - DHPP or DHLPP (Distemper, Hepatitis, Leptospirosis, Para influenza) - given annually.
 - Parvo - given annually, many times this is included in the DHLPP and indicated as DHLPP.
 - Bordetella (also called Kennel Cough or Tracheobronchitis) - given every six months or annually.
- I knowingly and freely assume all risks, both known and unknown, which may arise in connection with my participation in the Event, including, but not limited to, risk of or associated with injury and property damage including injury to me or my dog, illness, traveling to and from the Event, contact with other dogs or spectators at the Event, injuries sustained by and through other dogs or participants at the Event, or the condition of U.S. Bank Arena, even if arising from the negligence of the Releasees (defined below) or others, and assume full responsibility for my participation in the Event. If I feel that I or my dog are unable to safely and comfortably complete the Event, we agree to leave.
- I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, indemnify, and hold harmless Arena Management Holdings, LLC, and all of their respective officers, directors, officials, agents and/or employees, and sponsors, (the "Releasees"), with respect to any and all injury, disability, death, or loss or damage to person or property, whether arising from the negligence of the Releasees or otherwise, to the fullest extent permitted by law. I further agree to indemnify the Releasees with respect to any and all injury, disability, death or loss or damage to person or property that is caused by my dog or myself while attending the Event at U.S. Bank Arena.
- I hereby agree that the Releasees shall have the right to use the name, voice, likeness, photograph, videotaped footage and biographical information of my dog and/or myself, in whole or in part, for advertising, promotional and trade purposes in any and all media now known or hereafter developed, in perpetuity, without notice or further obligation to me and without further compensation, except where prohibited by law. I have read this Release of Liability, Assumption of Risk and Indemnification Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement.
